

**Resolution 037-2018**

**A RESOLUTION AWARDING THE BID FOR THE HILLCREST PARK IMPROVEMENT PROJECT PHASE 1 - GRADING.**

WHEREAS UCA § 10-7-717 Purpose of resolutions, states, "Unless otherwise required by law, the governing body may exercise all administrative powers by resolution . . ."

WHEREAS Providence City desires to provide for the health, safety, and welfare, and promote the prosperity, peace and good order, comfort, convenience, and aesthetics of the City and its present and future inhabitants and businesses.

WHEREAS Providence City desires to create a park on Parcel No. 02-219-0001, a 1.52-acre parcel located in the general area of 400 E 800 S, Providence UT; and

- Providence City advertised for bids for the Hillcrest Park Improvement Project Phase 1 – Grading.
- Providence City held a mandatory pre-bid meeting on October 9, 2018. Seven companies were represented at the meeting: Frontier Contracting, Whitaker Construction, Staker Parson Construction, Allied Underground Technology, Mike Liechty Grading, Legrand Johnson Construction, Acme Construction.
- Providence City received the following sealed bids prior to 5:00 p.m. on October 18, 2018; bids were publicly opened at 5:00 p.m. on October 19, 2018 at the Providence City Office Building, 164 N Gateway Dr. Providence UT.

- The Providence City Public Works Director reviewed the bids and recommends the bid be awarded to the low bid, Legrand Johnson Construction for \$39,999.99

- The bid for the Hillcrest Park Improvement Project Phase 1 – Grading shall be awarded to the low bid, Legrand Johnson Construction for \$39,999.99
- This resolution shall become effective immediately upon passage.
