Hearing Description: 2017 Budget Adjustments for the General Fund (GF)  
Increasing the GF Prior Year Funds revenue from \$80,000 to \$580,000 (\$500,000 increase); and increasing Public Works expenses \$445,000 for vehicles, equipment, and salt storage building; increasing Administrative Department expenses \$15,000 for council room audio/video equipment and furnishings; increasing Community Development Department expenses \$10,000 for Economic Development Plan consultant and preparation; and increasing Finance and Records Department expenses \$30,000 for equipment. Also increasing GF Revenue and Expenses \$4,775 based on actual revenue received. Also transferring \$24,000 from Administration Department to Finance and Records Department based on actual expenses.

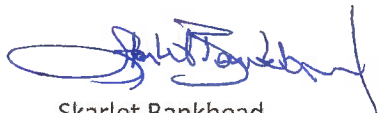

## Resolution 003-2017

A RESOLUTION ADJUSTING THE 2017 BUDGETS FOR THE GENERAL FUND.

WHEREAS UCA § 10-7-717 Purpose of resolutions, states, “Unless otherwise required by law, the governing body may exercise all administrative powers by resolution . . .”

WHEREAS Providence City desires to provide for the health, safety, and welfare, and promote the prosperity, peace and good order, comfort, convenience, and aesthetics of the City and its present and future inhabitants and businesses.

WHEREAS Providence City desires to adjust the 2017 General Fund Budget by allocating \$500,000 general fund money received in prior years for the following:

- Increase General Fund Revenue Prior Year Excess Funds from \$80,000 to \$580,000 (\$500,000 increase)
- Increase General Fund Expense Public Works – various line items:
  - Equipment for Public Works including: backhoe, bobtail dump truck with snow plow, basket truck, service truck, one-ton with dump bed; approximately \$370,000.
  - Public Works building for salt storage \$75,000
  - Total Public Works expense increase: \$445,000
- Increase General Fund Administrative Expense:
  - Audio/video equipment and furnishings for council room \$15,000
- Increase General Fund Community Development Expense
  - Economic Development Plan consultant and preparation \$10,000
- Increase General Fund Finance & Records Expense for Cemetery and Recreation:
  - Equipment for Cemetery and Recreation: Kubota snow blower attachment, field groomer/maintainer; \$30,000
- Total General Fund Expense increase: \$500,000

WHEREAS Providence City desires to make the following adjustments using actual revenue received in excess of budget during the current budget year:

- General Fund Revenue – Athletic Field Use Fees – increase from \$1,000 to \$2,600 (\$1,600 increase)
- General Fund Revenue – Soccer/Kickball Registration – increase from \$500 to \$675 (\$175 increase)
- General Fund Revenue – Park Donations – increase from \$5,000 to \$8,000 (\$3,000 increase)
  - Total General Fund Revenue adjustments using actual revenue increase: \$4,775
- General Fund Expense – Recreation Baseball/Softball Fields from \$32,000 to \$36,600 (\$4,600 increase)
- General Fund Expense – Recreation Soccer/Kickball from \$500 to \$675 (\$175 increase)
  - Total General Fund Expense increase based on actual revenue: \$4,775

WHEREAS Providence City desires to make the following adjustments based on actual expense between Budget Departments:

- General Fund Expense – Administration Department Salaries and Wages decrease from \$49,000 to \$30,000 (\$19,000 decrease)
- General Fund Expense – Administration Department Employee Benefits decrease from \$17,000

to \$12,000 (\$5,000 decrease)

- Total Administration Department decrease based on actual expense: \$24,000
- General Fund Expense – Finance & Records Department - Administration Salaries and Wages increase from \$56,000 to \$75,000 (\$19,000 increase)
- General Fund Expense – Finance & Records Department – Recreation Employee Benefits increase from \$10,000 to \$15,000 (\$5,000 increase)
  - Total Finance & Records Department increase based on actual expense: \$24,000

THEREFORE be it resolved by the Providence City Council:

- The above budget adjustments shall be approve; and
- This resolution shall become effective immediately upon passage.
