

## 2019 MVQG QUILT SHOW FEES, REGISTRATION & RULES

1. "Two People" is defined as more than one person involved in the construction or one person making the top, another quilting it.
2. Entries cannot have been exhibited in a prior MVQG show.
3. All quilts must include (the top, batting & backing) and be quilted by hand or machine. Exceptions are: yo-yo, crazy quilts, cathedral window, wearables and purses.
4. Each entry shall have a separate entry form, 2 photos (at least 4"x6" which may be computer generated) and a check made out to MVQG. (Okay to write one check for all entries)
  - Entry does NOT need to be completed for photo but needs to be recognizable as this is used for identification.
5. Entries MUST BE POSTMARKED no later than March 15, 2019. (Earlier entries are encouraged. Mail entries & check to: **Marsha Eibert; 2008 Ptarmigan St NW, Salem, OR 97304**. Up to 3 entries may be submitted. Indicate your choice on the entry form #1, 2, 3. Two may be judged (your choice). Every attempt will be made to hang all entries, but #3 will be the last hung.
6. Any quilt that is soiled, damaged or with a strong odor WILL NOT BE ACCEPTED.
7. Quilts are required to have a 4" wide (finished size) sleeve SEWN to the top of backside of quilt (NO PINS). Sew both top and bottom of the sleeve to the quilt. MAY BE BASTED FOR EASY REMOVAL IF DESIRED. *Instructions are available on MVQG website ([www.MidValleyQuiltGuild.com](http://www.MidValleyQuiltGuild.com)) or at the registration desk at meetings.*
8. Entry must have a cloth label sewn to the bottom of the backside of the quilt or inside a wearable or purse. Label to have entrant's name and name/pattern of item.
9. All Entries must be in a pillow case type CLOTH bag, one entry per bag.
  - Mark bag in ink or another label with **entrant's name, address, & phone number and quilt name.**

### QUILT DELIVERY

IN PERSON- (Quilt Depot)- Quilts to be delivered **Saturday April 13, 2019- 10am to 3pm at Scottish Rite Center: 4090 Commercial St SE, Salem, OR.** Someone else may deliver your quilt if necessary.

SHIPPED- Quilts may be mailed to Will-N-Bee's: **1555 12<sup>th</sup> St SE, Salem, OR. 97302**, include a copy of Entry Form(s). Postmark no later than March 1, 2019. We will do our best but will not guarantee the return of special packing material such as noodles, etc... Do not use packing peanuts or pellets of any kind as they may cause allergic reaction of those handling your quilts. If your quilt is to be returned by mail include a \$5 handling fee and a prepaid shipping label. Include copies of Entry Forms & a check with shipment. Insurance is the sole responsibility of Entrant.

### QUILT RETURN

**ALL QUILTS MUST REMAIN ON DISPLAY FOR THE DURATION OF THE SHOW. A receipt will be issued for each entry & MUST BE PRESENTED to retrieve those items on April 20, 2019 from 5:30pm to 6:30pm at the end of the show. Those mailed see instructions above.**

### JUDGED QUILTS

1. Two entries may be submitted for judging. They can be in the same or different categories. If more than 200 quilts are entered to be judged, we will judge your #1 choice first, then as many more as the Judges can complete. If your additional quilts are not Judged, your judging fee will be returned for that quilt. These quilts will be hung even if not judged.
2. The fee for Judging is \$10 per entry plus the \$5 hanging fee. This entry fee covers Judging expenses.
  - Each judged entry will receive a written critique.
3. The Show committee reserves the right, without notifying the exhibitor, to move an entry to a different category, if that is deemed appropriate.
4. No entry will be judged if the exhibitor (or any other participant in the making of the entry) is in the judging facility while the entry is being judged.
