

Minutes of the Garland City Council meeting held April 7, 2021, at 8:07 pm at the Garland City Building with the following council members present:

Mayor Miller called the meeting to order. Council Member Bourne gave the invocation and Council Member Peacock led the Pledge of Allegiance.

A motion to approve the agenda was made by Council Member Bingham. A second was made by Council Member Bourne with all council members present voting in favor of the motion.

Mayor Miller stated the next item on the agenda was the approval of the minutes from March 3, 2021.

Council Member Peacock commented that there was a correction to the minutes under the roll call vote. He stated that Council Member Munns did not vote. Mayor Miller commented it should be Peacock.

Council Member Bourne made a motion to approve the minutes from March 3, 2021, with that correction. A second was made by Council Member Peacock with all council members present voting in favor of the motion.

Mayor Miller stated the first item under new business was a vote on the school crossing at the high school.

Council Member Bourne made a motion that we approve for the school crossing where there are only 30 to 40 days left, where it is a very minimal cost for an hour, for the safety kids and the crazy traffic that we need to do that. A second was made by Council Member Peacock with all council members present voting in favor of the motion.

Mayor Miller stated the next item under new business was the shelter tech and code enforcement position.

Council Member Bingham made a motion that we vote on hiring a new shelter tech/code enforcement position if the funds are available by the end of this fiscal year. A second was made by Council Member Bourne with all council members present voting in favor of the motion.

Mayor Miller stated the next item is on the school resource officer and that really isn't up for a vote yet.

Council Member Bourne made a motion to table it until we get more information from the school district. A second was made by Council Member Ogborn with all council members present voting in favor of the motion.

Mayor Miller stated that we would be happy to hear from the principal or Officer Gailey with more information.

Mayor Miller stated the next item on the agenda was the financial review and asked if there were any questions. There were none.

Mayor Miller stated the next item on the agenda is the approval of the coding for accounts payable and payroll and utility account adjustments.

Council Member Bingham made a motion to approve the coding for payroll and accounts payable and utility account adjustments. A second was made by Council Member Ogborn with all council members present voting in favor of the motion.

Under Miscellaneous, Sharlet stated that a public notice will be running in the paper for two weeks stating that we will be holding municipal elections this year. The seats up for reelection are a four-year mayor seat, two four-year council member seats, and a two-year council member seat. The filing period will be June 1 thru 7.
