## Tropic Town Business Classification, Application and Fee Schedule

Businesses located in Tropic Town are grouped by Classification ~ Fees according to Grade. (\*) State's criteria of "Home Occupation" are exempt from a business licensing fee; but are still required to hold a valid Town License and pay taxes.

**Classification**: Home Occupation, Lodging/Accommodations, Restaurants/Concessionaires, Temporary Special Events and General Misc.

#### Dear Business Owner:

Thank you for applying for a business license from the Town of Tropic. The following is a list of taxes that must be charged related to services provided within Tropic Town limits.

Tropic Town Sales Tax 6.95% Tropic Town Resort Tax 1.00%

Transient Room Tax 4.25% (this applies to ALL nightly rental facilities, i.e.

(Motel/Hotel rooms, vacation rentals, bed and breakfasts, cabin rental, etc.)

Restaurant Tax 1.00%

Just as a reminder the official tax rates for the Town of Tropic can be found on the Utah Sales Tax Commission website: <a href="http://tax.utah.gov/sales/rates">http://tax.utah.gov/sales/rates</a>. Please contact the Sales Tax Commission directly to set up the appropriate tax accounts related to your business. They can be reached at 1-800-662-4335.

### Examples:

If you operate a nightly rental business, please ensure the total tax being charged is 12.20% (Sales 6.95% +Resort 1.00%, Transient Room Tax 4.25%)

If you operate a restaurant your total tax on food should be 8.95% (Sales 6.95% +Resort 1.00% Tax, Restaurant Tax 1.00%)

Any other business related sales of goods/services should be charging 7.95%, however please keep in mind there are exemptions to these rates. This is just a summary to help clear up confusion on what rates to charge within town limits.
