A RESOLUTION OF THE GOVERNING BODY OF TROPIC TOWN
AMENDING THE BUSINESS LICENSING FEES

Be it resolved by the Governing Bodies of Tropic Town, Garfield County, State of Utah:

WHEREAS, The Town Planning Commission and the Tropic Town Council have reviewed the Business Licensing Fees as outlined in the Tropic Town Business Licensing Ordinance #2018-7; and

WHEREAS, the governing bodies of the Town of Tropic desire to identify a separate fee to the Business Licensing Fee Schedule regarding Branch Establishments;

NOW, therefore the Governing Body of **Tropic Town** declares “Branch Establishments” be listed as a Classification in the Businesses License Ordinance & Business Classification Application and Fee Schedule and be charged a separate business licensing fee as follows:

- ~ A business licensing fee of twenty-five dollars (\$25) for each location within Tropic Town boundaries
- ~ Fees may be amended or revised from time-to-time by ordinance or resolution, as required by law.

This change to the Fee Schedule in the Tropic Town Business Licensing ordinance shall be put into effect upon passing.
