Mayor Sim Bell started the meeting at 6:30 PM with the Pledge of Allegiance. Eric Digerness is present to explain what he wants a business license for. He wants to start a company called Dig's Hydraulics. They will do hydraulic repair in their garage. They will not have any large equipment or machinery. Kathy made a motion to approve. Brandon Hatch 2nd. All in favor. Eric will give April his Tax ID number when he gets it.

Tawnia Smith is here to talk about the Softball/T-Ball season. She wants to get some hanging caddies to hold the helmets in and a few more helmets. The board approved of this. We will have a BBQ the last night of games which is June 25th.

Regular meeting was closed and public meeting was opened. Ordinance 26-2 – Water Supply was reviewed. Kathy added a few paragraphs to this and got the board's approval. We will also add that if there is a legal dispute the town may seek compensation for the legal fees incurred. Clay made a motion to accept this ordinance with the changes discussed. Brandon Hatch 2nd. All in favor. Public meeting closed and regular meeting reopened.

April asked if there were any questions on the minutes. There were no questions. Kathy made a motion to accept the minutes. Clay 2nd. All in favor. April read the bills. Brandon Hatch made a motion to accept the bills. Kathy 2nd. All in favor. Bank statements were passed around.

Brandon Miller will reach out to Bridger Valley fencing to see if they received our deposit and to see when they will be able to start. Courts Unlimited sent a contact. Sim signed it today. We will also send a check for a deposit and see when we can get on their schedule. Then we will need to get the basketball hoops and if we have any money left, we are thinking about getting some portable bleachers. Kaleb is wondering if he needs to move any electrical or sprinklers before they do the fencing. Brandon will call them and see how much minimum space they need to place the mow curbing. Late summer is the goal to have the project done.


Brandon Miller was not able to reach out to Jeff & Denise Hamburger about the 5K run. He will talk to them before the next meeting.

Tourism Grant was discussed next. Portable bleachers were discussed. Kathy wants to do Christmas lights & decorations at the park. She will work on getting some quotes for these. A new fence around the park was discussed. Kaleb will measure the fence and we will get a bid from Bridger Valley Fencing.


Overdue water bills were discussed. PEHP insurance is going up \$125 a month for next fiscal year. We need to renew it by June. The board approved of renewing it. We have also had some people ask if we are hiring for the summer. Kaleb said that 2 of the boys from last year have said they are coming back. We will have them fill out applications and go from there.

Clay wants to move the solar panel flashing speed limit signs closer to the 30 MPH zone. Kaleb said that we could do that, but we will need to buy 1 solar panel and 1 battery. He will let April know for sure. Bradley Holmes will be doing the streaming for the local sports games. The town will do the elite sponsorship for \$2,500 per year. Sim said that Steve Myers will sale his reservoir lot shares in September. He has it leased out for the summer. He wants the amount all at once.

Brandon Hatch made a motion to close the meeting at 7:40 PM. Clay 2nd. All in favor.
