Mayor Bell called the meeting to order at 6:30 PM. The Pledge of Allegiance was recited. The floor was turned over to Laurel Telford. He is here to discuss his opposition to the town taking any grant money and has concerns about the town's water security. One of his questions was, "What do we want Randolph to be?" These topics were discussed.

Brandon Miller approved the minutes from last month. Kathy 2<sup>nd</sup>. All in favor. April read the bills. Clay approved the bills. Kathy 2<sup>nd</sup>. All in favor.

We had six seniors turn in an application for the Town of Randolph Scholarship this year. They are Tyla Pugmire, Paige Smith, Braedyn Alder, Brookell Crompton, Clare Shinkle, and Dylan Wasden. The board decided to give each of them \$400.

The FY 2027 Budget was discussed. April prepared a preliminary budget for the board to review. She will talk to our accountant about a few issues and then email the final copy to the board in a few weeks. We will have a Public Budget meeting on June 10, 2026. Kaleb will get some prices for valves and new hydrants that we need to replace.

The fencing on the tennis court is going up. Brandon Miller thinks it should be done within a week. The posts and the mow curb are done. The surfacing should be done by the end of July. We will still need to order the basketball posts and hoops. If there is any leftover money, we will get some portable bleachers to use at town sports events and at fair week. Brandon Miller is wondering if we can use the old basketball posts. It was decided that we will do 2 basketball hoops instead of 4. Brandon Miller said that the light poles are looking pretty bad, they stand out more now that we are getting the new fence around the tennis

court. One of them is leaning over quite a bit. Kathy said that Rocky Mountain Power might donate some new or used poles.

Jeff & Denise Hamburger said that they would oversee the 5K run again this year.

Tourism Grant for next year was discussed. Kathy has been working on a Christmas Light design and budget. She has some questions about the power supply. Kaleb answered her questions. He will get her a map of where the power sources are so she can plan where to put things. Sim wants to approach the tourism board for some money for a fishing derby next spring. Kaleb said that the State would be willing to plant some fish. Clay will ask Eldin some suggestions for the fishing derby.

Kaleb talked to the Custom Fence Company about re-doing the fence around the park in the same black finished fence that is around the tennis court. We will use the existing posts and put a black sleeve over them. The board decided to redo the fencing past the double gates. Kathy thinks that we should measure the chain link that we take off and post it for sell. Brandon Miller wants to see how much it would cost to replace the fencing at the baseball diamond.

The softball BBQ will be on June 25<sup>th</sup>. April will get the same food and supplies as last year and double the lemonade.

Overdue water bills were discussed. The BLM got ahold of Sim and told him that they got the grant that they applied for. They want the town board to be involved in the planning.

The board decided to hire the three boys that worked for us last summer. We had several more applications. Kaleb will let them know.

Zion's Bank is wanting to put a new sign in. April asked if we have any regulations on signs. It is going to be a little shorter than the one that is there now, but wider. Kathy is wondering if it will block the view of the highway. Brandon Miller looked up the state requirements for signs and that was discussed. Kaleb will check with Ben from UDOT and see if he knows of any regulations and to see if they have any problems with this.


Kathy made a motion to close the meeting at 8:23 PM. Brandon Miller 2<sup>nd</sup>. All in favor.
