a. Invoice Register:

Jerry Smith asked about 10-43-230, in regards to mileage and travel reimbursement; differences may be seen

here still due to COVID and in-person trainings being down still.

 Mayor Cutler excused Jeff Holden; he is sick. Mayor Cutler did report that Jeff was in staff meeting this morning and had reported that the pot holes on the west end of town on 6600 South, had been repaired.

SHERIFF'S REPORT: (00:21:03)

Presenter: Lt. Ryan

- Lt. Ryan reviewed the December 2021 stats for Uintah, that were sent previously from the Sheriff's office; nothing major to report.
- Lt. Ryan reported that the Flock camera is set up in Uintah now, and will go live/active once Huntsville is set up as well; these cameras will mostly assist with crimes on a larger scale, such as stolen vehicles, for example.
- Lt. Ryan advised that the VIPS Program will have a vehicle in this area soon, and it may be parked here at City Hall or at the Fire Station; this vehicle will be used to patrol Uintah City and Uintah Highlands.
- Mayor Cutler asked Lt. Ryan about rumors he had heard about a possible Jail expansion; Lt. Ryan said there may be
 two more pods being added, and a mental health wing, but this is all very preliminary.
