AGENDA ITEMS:

1. **MEETING CALL TO ORDER:** Mayor Cutler called the meeting to order at 7:01 p.m.

2. **PUBLIC COMMENT:**

- Mr. Dye stated that Mr. Dixon is going to be expanding his property in the future and I have looked at the City's general plan and there is a road that goes across the Dye farm that we have had no knowledge of up until this point. There is currently a right of way that was omitted on the general plan that I would like to see put on there. There is a north-south road that has been put on the city's general plan that we had no knowledge of even after attending the planning commission meetings regarding roads. We did know of road along the east-west corridor in the area.
- Mayor Cutler stated that the roads that are in the general plan aren't written in stone so there is some leeway as properties are developed. You need to meet with the planning commission so they can alleviate your concerns. Mr. Dye reiterated that he would like to make sure that our interests are looked after. There is an existing right-of-way that currently accesses the Dye property, which is owned by Scott Dixon, so we would like to see that put on the general plan. Council Member Roberts asked if the right-of-way was on the plat and Mr. Dye stated that is on Weber County's. Mayor Cutler mentioned that when we first started talking about the east-west road, one of the biggest drivers was given to us by our City Engineer because they were looking at the future when we get off of septic tanks and get a sewer system. He also mentioned to Mr. Dye that you should decide what you want to do with that property before you going to planning commission to see if your plans line up with Mr. Dixon's so that it could be beneficial for both of you.
- Dan Combe stated that on the general plan there is a road that goes right down the middle of his nursery. After going down this road with the City engineer, the general plan is not one set idea, but there must be a spot for the sewer to go when that time comes. The engineers didn't look at every right of way, just the general plan.


