AGENDA ITEMS:

1. MEETING CALL TO ORDER: Mayor Cutler called the meeting to order for April 5th, 2022.

PLEDGE OF ALLEGIANCE: Led by Dave Boothe.

<u>CONFLICT OF INTEREST</u>: Council members are required by law to file a public disclosure statement with the City Recorder listing business interests and investments that could create a conflict of interest with the duties of the Council Member. When a matter in which a Council member has a business or investment interest appears on the Council agenda, the Council member must publicly disclose that interest.

Mayor Cutler asked the Council if they had any conflicts of interest with tonight's agenda; there were none.

Mayor Cutler excused Council Member Kristi Bell; she is out of town in Goblin Valley.

2. PUBLIC COMMENT (2 minutes per person): (00:02:54)

- Mayor Cutler asked Weber County Lt. Ryan to introduced Corporal Jared Flandro to us and told us why he is here.
- Lt. Ryan mentioned they held an awards banquet 2 Saturdays ago, Corporal Flandro received a prestigious award for his acts on a structure fire in South Ogden. Lt. Ryan had Corporal Flandro take over and tell the story about what happened.
- Corporal Flandro stated it was September 4, 2021 him and Deputy MacAfee were at the 7/11 on Riverdale Road. He had not heard anything on his headset but he saw a couple Riverdale Officers speeding down the road, they decided to go check the CAD system to see what is going on. They pull up the CAD system; which is their call system, South Ogden was reporting active structure fire in South Ogden and reported that 5 children are trapped in the home. They decided to take off towards the scene, they arrived on scene just after fire did. They were asking around trying to figure out what happened, at the time all we knew was that the carport house, the kitchen and everything was fully engulfed in the home. There were flames up to the ceiling and what they were being told was that there were 5 children trapped in the home, 3 or 4 upstairs and 1 or 2 in the basement depending on if someone had gone to bed. The mom was able to make it out of the house but at that time none of the children had reportedly made it out. At the time there was 1 fire engine on scene and 3 firefighters. 1 firefight; the one that runs the truck, the engineer was getting the water ready and the others were getting their protective gear on. Corporal Flandro knowing how to handle a fire, he grabs a hose, asked the engineer to charge the hose, and while directing Deputy MacAfee they put water on the fire in hopes that the only way of these children might survive is if they can get the fire under control as quickly as possible so the firefighters can get in there before any potential harm can be done to the children. They fought the fire until they ran out of water, as more firefighters started coming on scene he started talking to the parents or landlord trying to find out where the children were in the house. They found out they may be in an upstairs bedroom, he ran and grabbed a latter off the back of the truck, and pushed it up to the back of the house. He started explaining to firefighters as they came running around the corner where they believed the children were. They got up there with their gear, and in the process, he ended up with 2nd degree burns across his forearm from being close to the fire. They found out in the end that the youngest was 17 and all 5 children had gone to WinCo for a food run, probably 20. minutes before the fire. They had been there for about half and hour before they found out that there were no children trapped in the house. Thankfully, they had left prior to the fire starting.
- Weber County Sheriff's Department presented Corporal Flandro with a Medal of Valor award.
- Corporal Flandro thanked Mayor Cutler for his support and everything he gives them. He thanked Council for
 everything they do for the Sheriff's Department that enables them to be available, not only in Uintah but in the near by
 cities and letting them do good work to keeping the community safe.
- Lt. Ryan mentioned how humble Corporal Flandro is. A day or 2 later, they do employees of the month and they depend on their Sergeants and Corporals to send in submissions of what everyone is doing throughout the month and what they should be recognized for. Corporal Flandro entered in Deputy Arbogast who was on scene helping, in for an award. Lt. Ryan read his report and submission that Corporal Flandro put in and a week later Lt. Ryan was approached about Corporal Flandro's story.

- Jeff Holden stated it was a water leak and it's over \$1,000 so they need approval. During an emergency water leak it tough to get 3 bids and wait the time frame to get 3 bids. Jeff had a local resident; which is a contractor help him fix it. At the time, Jeff went with what he thought was the cheapest option.
- Jerry Smith motioned to approve the Emergency Repairs made to the service line located on 1540 E for \$1,255,00
