MEETING MINUTES:

1. **MEETING CALL TO ORDER:** Mayor Flitton called the meeting to order.

PLEDGE OF ALLEGIANCE: Led by Michelle Roberts

2. **DISCUSSION ON FISCAL YEAR 2018-2019 BUDGET:** (00:01:00)

Presenter: Mayor Flitton

- Mayor Flitton started the meeting with asking the Council if they had any new items for the budget that have not been in the previous year's budget.
- Michelle Roberts stated that she felt that we need to talk about salaries for employees.
- Salaries were reviewed and discussed. It was suggested that we match the job to the market. Michelle Roberts stated that she would do an analysis and compare what other cities were currently paying their employees and share that information with the Council.
- Jerry Smith wanted to make sure that the Council take into consideration what the City pays for the State Retirement and insurance benefits and stated that should be added to the total of what the City pays the employee.
- Gordon Cutler stated that we have had a 66% turnover with our employees these past few years and we should invest in our employees to prevent further turnover.
- Mayor Flitton commented that we have the funds this year for an increase and questioned the Council if they would be willing to face a tax increase if needed in the future for this increase.
- It was discussed that what the city currently collects for taxes the services we receive for those taxes are very reasonable.
- Mayor Flitton asked Chief Sacco to have his projection for his budget to the Mayor as soon as he could and asked the Chief to submit his best guess as to how much revenue we would receive for one wild land fire deployment. Mayor Flitton stated to use the low end of the guess to budget for the wild land fire revenue account.
- Mayor Flitton asked Gordon how much of the Class C Road funds would be needed to crack seal the entire city as planned. Gordon stated that he and Jeff were currently working on quotes.
- Mayor Flitton explained that the spreadsheet he is using for the budget would be sent to the Council members for review. He explained that he added column M and titled it 2017-2018 Proposed and column N is the run rate for the rest of the year. He asked each of the Council to review and double check their departments for changes or additions.
- It was discussed that we would continue discussions on the budget at the next work session scheduled for May 15th.

Michelle Roberts motioned to adjourn the meeting.
