## MEETING MINUTES:

1. **MEETING CALL TO ORDER:** Mayor Flitton called the meeting to order.

2. **DISCUSSION ON FISCAL YEAR 2018-2019 BUDGET:** (00:01:00)

Presenter: Mayor Flitton

- Mayor Flitton stated that we need to get through this tonight so that we can fine tune and have ready for our first meeting in June.
- The Council discussed the URS rates and benefits that the City pays for employees. Mayor Flitton explained Michelle Roberts complied and submitted a spreadsheet comparing neighboring cities and what they pay their employees. The Council reviewed the different rates for the different positions and compared them to what the City pays to determine if we are in line with the industry.
- Mayor Flitton stated that it appears that we are comparative with other cities of our size and stated that it was up to the Council to determine what they wanted to compensate our employees.
- It was discussed to increase the City Recorder position twelve percent and where the Public Works position was increased prior to Jeff Holden coming back they would increase it this year by five percent. The part time Public Works and Custodian by three percent and the Court Clerk by five percent.
- Mayor Flitton asked the Council if they had anything to add to the enterprise funds, water, garbage and storm water that isn't already in the budget. The three funds were reviewed and discussed.
- Mayor Flitton asked Mike Ulrich to finalize the salaries and benefit figures and figure the administration transfers from the enterprise accounts. He requested that Mike and Darinda send out the preliminary spreadsheet to the Council for their review prior to the next meeting.
