# 3. APPROVAL OF CITY COUNCIL MEETING MINUTES HELD JUNE 6, 2023:

### 4. TREASURERS REPORT:

- a) Invoice Register May 2023
  - Council Member Bell motioned to approve the invoice register from May 1-31, 2023.

  - Mr. Ulrich explained that our sales tax is strong, and our interest is as well. We are starting to see an
    increased number of building permits.
  - He is projecting that we will have excess money in our budget come June, which will put us over the state limit.
  - Revenue is still coming in strong. We have not finished the water tanks, so that money will carry over into
    the next year so that we can finish that project. We will be using the money from our savings to complete the
    water project. Council Member Smith asked how we can appropriate money from this year into next year's
    budget. Mr. Ulrich explained that we just budget that money from our PTIF account to Zion's.

- Mr. Ulrich explained that we have increases in revenues and increases in expenditures to balance the budget. We
  have more than enough to cover the budget expenditures. For example, the wages in public works are due to the
  overtime from all the snowplowing.
- This is something that we do every year. The city council can reallocate the funds within the departments at any time.
   Because we are increasing the funds, we must have a public hearing. Mayor Cutler thanked Mr. Ulrich for explaining the process. We also need to increase the stormwater depreciation, so that is included.

- Council Member Bell motioned to approve Ordinance 279-23 finalizing and adopting the budget for fiscal year 2023 and adopting the certified tax rate that the county has provided.

# 13. <u>APPROVAL/ACTION ON INTERLOCAL COOPERATION AGREEMENT FOR THE DISTRIBUTION OF CORONAVIRUS STATE AND LOCAL RECOVERY FUNDS FOR THE CONSTRUCTION OF A NEW CHILDREN'S JUSTICE CENTER.</u>

- Mayor Cutter explained that this is regarding the Children's Justice Center. This is where the children involved in law
  enforcement action can be interviewed in a place where they can feel safe and secure. They had a figure for every
  City and what they want each of them to pay and Uintah's amount is \$7,000. We were able to split this payment into
  two payments. Council Member Bell stated that this is a service that is highly contributed to and is something that is
  needed.
- Council Member Bell motioned to approve the Interlocal Cooperation Agreement for the Distribution of Coronavirus State and Local Recovery Funds for the Construction of a New Children's Justice Center.
- Council Member Smith seconded the motion.

The base rate will be an \$8 increase with no additional increase within the tiers of the water rate structure.
