MEETING MINUTES:

1. **MEETING CALL TO ORDER:** Mayor Cutler called the meeting to order for Tuesday August 3rd, 2021.
PLEDGE OF ALLEGIANCE: Led by Kristi Bell.
CONFLICT OF INTEREST: Council members are required by law to file a public disclosure statement with the City Recorder listing business interests and investments that could create a conflict of interest with the duties of the Council Member. When a matter in which a Council member has a business or investment interest appears on the Council agenda, the Council member must publicly disclose that interest.
Mayor Cutler asked the Council if they had any conflicts of interest with tonight's agenda; there were none.
2. **PUBLIC COMMENT (2 minutes per person):** (00:01:00)

3. **APPROVAL OF WORK SESSION MINUTES HELD JULY 20TH, 2021:** (00:01:38)
Presenter: Mayor Cutler
 - Mayor Cutler explained that there was one change to these minutes, but that this change was done prior.
 - Kristi Bell motioned to approve the Work Session minutes held July 20th, 2021.
 - Dave Boothe seconded the motion.
 - Mayor Cutler asked if there was any discussion on the motion; there were none.

4. **APPROVAL OF CITY COUNCIL MEETING MINUTES HELD JULY 20TH, 2021:** (00:02:18)
Presenter: Mayor Cutler
 - City Council reviewed the City Council Meeting minutes from July 20th, 2021.
 - Dave Boothe motioned to approve the City Council Meeting minutes from July 20th, 2021.
 - Kristi Bell seconded the motion.
 - Mayor Cutler asked if there was any discussion on the motion; there were none.
 - All in favor; the motion passed.
5. **THE MAJOR BRENT TAYLOR FOUNDATION – WEBER REMEMBERS, THE 9/11 PROJECT PRESENTATION:** (00:02:40)
Presenter: Johnny Ferry
 - Johnny Ferry introduced himself and presented a power-point presentation of, "WEber Remembers: The 9/11 Project."
 - Uintah City had been asked to submit a few photos, a copy of the City logo, as well as three to four sentences about what brings Uintah together or makes the city unique; Council Member Kristi Bell has provided this information for this project.
 - Johnny explained that the Major Brent Taylor Foundation, in collaboration with local law enforcement, military, and fire, have all partnered to honor the lives lost and the sacrifices made in service to us all as a result of 9/11/01. They have created an immersive, interactive memorial museum experience that will allow the public to see, hear, and touch things that tell the story of September 11, 2001. The event will run from September 9th through September 11th, 2021 at the Weber County Fairgrounds.
6. **OGDEN-WEBER TECHNICAL COLLEGE PRESENTATION:** (00:16:25)
Presenter: President Jim Taggart
 - President Jim Taggart, and Development Director Brynn Murdock, of Ogden-Weber Technical College explained that they are present tonight as part of the College's 50th anniversary.
 - President Taggart gave a brief overview of the College; it was founded in April of 1971, growing from 96 students to serving over 6,000 students a year, the college provides technical training for the employers in this community, and every student who graduates has an average of 5-7 jobs waiting for them, with many if not all students graduating debt free.
 - President Taggart wished to thank the municipalities in Weber County, and all of Weber County government, for their support of the College through the years. In an effort to show their appreciation, scholarships are being awarded to

each municipality in Weber County, with a full-year scholarship for the City Council to grant to a member of the community of Uintah.

- Brynn Murdock presented the City Council with a full tuition scholarship for the City to offer a resident of Uintah, or an employee of Uintah, or the employee's dependent. A packet was given to the Council with all of the information needed, and the Council was invited to take a tour of the campus.
- Mayor Cutler and City Council expressed their thanks for this presentation.

7. **PLANNING COMMISSION REPORT TO COUNCIL:** (00:26:20)

- Robert Guiller reported that there was not a Planning Commission meeting held in July because it was not posted within the permitted guidelines, therefore it was postponed until August.
- Robert advised that Jeff Monroe was present this evening to review the changes that had been done in June's meeting, in reference to a few chapters in the City's Title 9 – Land use Regulations ordinance.
- Jeff Monroe discussed the prior changes done with the Council, and advised that he has further reviewed changes; Jeff expressed he feels there may be some further adjustments that need to be made and is asking to table the recommendations that were done prior by the Planning Commission, so these may be further reviewed and then those recommendations may be presented to the Council at a later date.
- Mayor Cutler deferred to Council Member Dave Boothe as he is over Planning Commission; Dave had a question regarding set back requirements, and Jeff advised that those are being addressed in this ordinance.
- Dave Boothe made a motion to accept the recommendation to table this item from the Planning Commission, until next month.
- The motion was seconded by Kristi Bell.

Dave Boothe asked if this will affect Uintah Business Park's final building being constructed, and Mayor Cutler advised that it will not because that has already been handled and done.
