- a) Invoice Register August 2023

- Mr. Ulrich explained that the URS rates haven't changed from last year to this year. We are paying about 16% for our employees. This needs to be approved every fiscal year.

next week with our engineers to see what will be best for the project. We are waiting for approval from the
state to get our water tanks online. FX has been great to work with and they have been very transparent with
everything they are doing.

There was a water leak today at 6600 and we got that taken care of. We received the plan for the septic
system from the engineer for the restroom up at the cemetery and the next step is to submit a permit to the
Weber-Morgan Health Department.

7. DISCUSSION ON ROAD REPAIRS ON 6600:

- Mr. Holden stated that he received three bids for the road repairs that need to be done on 6600. He suggested approving the bid from Advanced Paving because it is quoted at 4800 square feet where the Anderson Asphalt quote only includes 2995 square feet. The bids we received were from Advanced Paving in the amount of \$17,780.00, Anderson Asphalt in the amount of \$16,173.01, and the last one was from Miller Paving Inc. for \$22,134.00.
