Subject: Fire Department October 2013 Report

Summary Recommendations: This report is for informational purposes as part of the Fire Department’s Monthly Report to the City Council.

Description:

- A. **Topic:** Fire Department Monthly Update.
- B. **Background/History:** On July 16, 2013 the Fire Department presented a comprehensive fire service presentation. At that time the Council directed staff to begin providing comprehensive Monthly Reports regarding department operations.
- C. **Analysis:** Figure 1 shows the total calls for service for 2012. Please note that 2013 is the call volume for January through October of this calendar year.





Figure 2: Monthly Call Volume Longitudinal




Figure 3 Monthly EMS calls 2012, and January through September 2013.




Figure 4 shows the First Responder Calls response, broken down by responding agency.¹




Figure 5 Monthly Fire Calls 2012, and January through September 2013





Figure 7: Monthly FIRE Calls by Type
