

ORDINANCE NO. 260-20

**AN ORDINANCE OF THE CITY COUNCIL OF UINTAH CITY, UTAH,
AMENDING THE BUDGET FOR FISCAL YEAR 2020-2021; PROVIDING FOR A
SAVINGS AND SEVERABILITY CLAUSE, AND PROVIDING AN EFFECTIVE DATE**

WHEREAS, the City Council of Uintah City (herein "City") is a municipal corporation duly organized and existing under the laws of the State of Utah; and,

WHEREAS, the City Council finds that in conformance with the provisions of UCA § 10-3-717, the governing body of the city may exercise all administrative powers by ordinance; and,

WHEREAS, a public hearing was duly advertised, scheduled, and held on October 6th, 2020; and

NOW THEREFORE, be it hereby ordained and enacted by the City Council of the City of Uintah that the Amended Budget for Fiscal Year 2020-2021 shall be as follows:

SECTION 1. A Budget Amendments for fiscal year 2020-2021 is as listed, including all budget amendments, within each fund, according to the listing as authorized:
