After the presentation, the following questions were asked:

- Brent Stuart: Who is assembling the guns? Will there be other employees? There will only be 2 employees, Thomas Sr and Thomas Jr, and Thomas Jr will be doing all the machining and assembling of guns. What is the square footage of the space being leased? 2400 sq ft. Are you doing any casting? No, the extent of the work is forming the receivers and welding them together. How are you containing welding fumes? Each booth has a self-contained ventilation system and will be cycled back into the building. Can you show us the fence around the warehouse? Google maps was brought up on the tv, and Thomas pointed out the warehouse and the fence surrounding it.
- Debra Wickizer: How are you containing the area where testing is done? They have a commercial bullet trap that is contained and filtered. Will there be any outside storage? No, and there is no storefront. Are you connected to the loading dock or will you be transporting inventory outside? The buildings are detached and they will be using an alley to move between the two, but by federal law nothing can leave their building unescorted. Also, both warehouse and loading dock are behind a locked gate and not accessible to the public. Are there lavatory facilities? Yes. Will you do any bluing? No, there is a new procedure that works better Do you bring in preformed stocks? Yes
- Jon Arends: What size caliber of rounds? Anything from 22mm to 308. Will there be ammo reloading? No and they will not manufacture any. How much ammo will you be keeping on inventory? A small number of 500 round cases of various caliber. What types of metals will you be welding? Mostly steel and aluminum with some titanium. What will you be grinding and bead blasting? Components come packed in grease. so they will be blasting off the grease. All media is contained and reused. Is anything carcinogenic? Lead for the bullets. How many times a day will you be testing? Not more than 2-3 times per day, but there will be multiple rounds with each test. Is the building insulated? How much noise is expected when testing? Because of the bullet trap and insulation, the noise outside the building won't be any louder than a hammer striking metal. What are your hours of operation? 9-5. Is there an emergency action plan? Yes, there are plans in place for accidents and fire. There are multiple fire extinguishers including special ones that put out metal fires.
- Scott Dixon: Do we have any special conditions for zoning for this type of business? There is nothing in the city ordinance so it's up to planning commission to set the conditions. Did we address the issues from the public hearing? Yes
- Glen Woolsey: Does the fire marshall have any special conditions? That would be taken care of before the business license is obtained. How do you store firearms that have been completed and serialized? ATF requires 2 locks, they have 3. The gate leading to the warehouse, the warehouse itself is locked and the firearms are kept in a vault. What will happen to the machine filings? It will all be recycled. There are no hazmat concerns because everything is water based.
- Thomas Carpenter invited Planning Commission member to tour the facility when they were up and running.

Debra suggested that it would be advantageous to have an address posted. She drove around for quite a while and couldn't find it. Posting an address may help in the event of an emergency.

Brent stated that since there were no modifications to the building, a building

permit isn't needed.

Scott stated that he was impressed with the presentation. They knew their business and presented it well.

Brent made a motion to approve the CUP contingent upon obtaining a business license and since this is a new type of business, we do a 6 month review once it is up and running. Jon seconded the motion. All in favor – motion passed.
