Kim stated that they had previously submitted plans for this area but that the septic would have become a problem as they can only have so much liquid going through there. They were afraid that if they built the building to house offices and other types of businesses (Kim said "you don't always know what type of tenants you will get"), they would be at capacity. They have changed their plans for this building. The building will now house climate-controlled RV storage on the first floor. They have been working with Mike Romero on the RV storage idea. The upper floors may have some office space as well as storage. This will ensure that the septic can handle the fluid. This building will stand at about 37 feet tall where the other buildings are only 33 FT. They have a good strong HOA cash account that has helped make this possible

5. Discussion/ Action: Water Ordinance that has been adapted to fit Uintah City. Debra Wickizer and Daniel Combe have worked on adapting the version that is being presented tonight from the Weber Basin guideline. They have worked hard to tailor

the ordinance to better fit Uintah's needs. We have provided a copy of the proposed ordinance for the City Council.

- 6. Discussion/ Action: Redd's request to De Annex. Commissioner Wickizer has been researching possible options for the Redd's to be able to stay in the city boundaries and still accommodate their wishes. She has found that several other cities have made allowances for shooting in the city limits with specific restrictions. It requires a 5–10-acre property minimum. They would be required to have a Business License and a CUP. We will talk about this more at the next Planning Commission Meeting.
