### PRIMARY ELECTION ORDINANCE for the Town of CEDAR FORT

BE IT ORDAINED by the Town Council of the Town of Cedar Fort, Utah County, Utah, that an ordinance relating to the establishment of Primary Elections for the Town of Cedar Fort be enacted as follows:

### 1.0 OVERVIEW

Establishment of and adoption of an ordinance of a Primary Election System for nominating and electing candidates for municipal offices.

### 2.0 PURPOSE

This ordinance is enacted to establish the procedure necessary for calling a Primary Election as follows:

- 2.1 Election for mayor and council members shall be conducted according to the municipal election section of the Utah Code reference: 20A-9-404 (1) and (2).
- 2.2 This ordinance provides that the candidates for mayor and council members to be nominated at a primary election, if required.

A primary election will be held only when the number of candidates filing for an office exceeds twice the number to be elected. The candidates nominated at the primary election plus candidates that were not required to run in the primary are to be placed on the November ballot.

The primary election, if required as stated above, will be held on the Tuesday following the first Monday in the October before the regular municipal election.

2.3 - All ordinances of the Town which are inconsistent with the provisions of this ordinance are hereby repealed.
