AN ORDINANCE ADOPTING A TOTAL **B**AN ON THE USE OF **F**IREWORKS, FIREARMS, AND FIRE WITHIN THE TOWN LIMITS

- WHEREAS, in 2011 the Utah legislature modified the state law by amending the types of fireworks which may be discharged in Utah which appears to have increased the use of fireworks within the Town; and
- WHEREAS, in 2012 Utah State law changed the dates allowed for discharge of fireworks; and
- WHEREAS, there has been and may be in the future a high risk of fire during some of the time when fireworks are allowed by State Law to be discharged; and
- WHEREAS, the Governor of the State of Utah has recommended that cities and towns consider a ban on fireworks when there is high fire danger; and
- WHEREAS, the Town Council finds it is in the best interest of the Town and the general health, safety and welfare of the public that this ordinance should be passed; and
- WHEREAS, the Town of Cedar Fort is in a particular situation of being an urban interface with very few locations within the town that do not have adjacent vacant lots or uncultivated areas, and
- WHEREAS, the Town AHJ (Town Fire Chief) concurs with the potential serious nature of fire danger threat, and
- **WHEREAS**, the State Interagency Fire group may initiated a statewide fire restriction in all unincorporated areas during high fire danger seasons,

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THIS TOWN AS FOLLOWS:

1. Definition

All terms relating to fireworks used in this ordinance shall have the same meaning as they are defined in Utah Code Ann. 53-7-202 (Utah Fire Prevention Act).

2. Discharge and Possession of Fireworks Banned at SPECIFIED times as follows:

- a. The AHJ (Fire Chief) shall consult with the Town Council to determine if a potential high-fire-danger exists.
- b. If the Council concurs with the AHJ, the Council shall issue a public notice.
- c. The full provisions and authority of this ordinance shall then be invoked.
- d. A Public Notice shall be posted in three (3) public places indicating that the ban on fireworks, firearms, and open fires is now in effect. The Notice may indicate a terminating date or may be open-ended. If open-ended,

another notice shall be posted when the fire danger has passed and the ban is lifted.

3. Provisions of the ordinance

It shall be unlawful for any person to:

- a. Discharge any fireworks in this Town at any time a Public Notice is in effect, and until such time as the Public Notice has been lifted.,
- Set, build, maintain, attend or use open fire of any kind, except in campfires built within facilities provided for them in permanently improved places of habitation,
- c. Smoke, except within an enclosed vehicle or building, or developed site with three feet of cleared soil,
- d. Discharge tracer ammunition or other pyrotechnic devices.

4. Enforcement

- a. Every officer charged with enforcement of State and municipal laws including the Fire Marshal is hereby charged with the responsibility to enforce this ordinance.
- b. Fireworks possessed, sold or offered for sale in violation of this ordinance may be seized and destroyed and the license of the person selling or offering fireworks for sale may be revoked.

5. Punishment

Violation of this ordinance shall be a class B misdemeanor punishable by both fine and imprisonment as set forth in Utah law.

Additionally, anyone who causes a fire due to the use of fireworks, campfire, smoking, tracer ammunition or other pyrotechnic devices within the Town limits will be held financially responsible for any costs associated with fighting the fire.

6. Effective Date

This ordinance shall take effect immediately upon passing. Provisions of the ordinance shall be activated or deactivated by the AHJ and Council upon posting of a Public Notice.
