

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <http://www.mcdonaldsvacuums.com/> and McDonald's Sewing & Vacuum and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to McDonald's Sewing & Vacuum include <http://www.mcdonaldsvacuums.com/> and McDonald's Sew & Vac. Collection of your Personal Information

In order to better provide you with products and services offered on our Site, McDonald's Sew & Vac may collect personally identifiable information, such as your:

- public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;

 - Comply with an existing legal obligation; or
