This Raspberry Days venue is held indoors at the Garden City Complex in the Lakeside Bldg on 300 West and is open to residents of Rich County, Utah and Bear Lake County, Idaho ONLY!

We accept handcrafted, designed, and/or produced items done by you (we reserve the right to remove any items that do not represent the intent/spirit of our craft fair). So, whether your specialty is wood crafts, painting, photography, needlework, jewelry design, metal art, locally produced jams, jellies, candies, or any other product you make yourself, we invite you to participate in our 9<sup>th</sup> Annual Raspberry Days Bear Lake Valley Craft Fair (BLVCF). Resale items are strictly forbidden.

The 2018 Craft Fair will be held indoors at the Town Center in Garden City, August 2-4. The hours are 10 am -7 pm Thursday and Friday and 10 am to 6 pm on Saturday. Vendors must attend all three days so please have enough inventory. Booths are approximately 10' x 10' and cost \$50.00 which must be paid with the application. No refunds will be given after July 1, 2018.

You will be responsible for the complete set up and tear down of your booth including tables, chairs, and all display items. Thumbtacks or anything that leaves holes in the wall are forbidden. You must keep your booth clean and litter free with extraneous items hidden under the tables. Doors will be locked at night but we cannot be responsible for lost, stolen, or damaged items.

Young children and pets will not be allowed to hang-out with you. Older children who are there to help run the booth are allowed as long as they do not bother the other vendors.

You are responsible for collecting and remitting Utah State Sales Taxes and will be provided a form for that purpose.

I have read, understand, and will abide by the Bear Lake Valley Craft Fair Agreement.
