MONTHLY RENTAL AGREEMENT

The instrument described herein is rented to the Customer signing below upon the following terms and conditions.

1. This is a MONTHLY RENTAL paid in advance. The rental may be returned at anytime after the minimum rental period of 3 months. *The Violin Shop* guarantees the condition of the instrument at the time of rental. 50% of rent paid is accrued equity and may be applied to the purchase of any rental grade instrument.

Rental equity may also be applied up to 50% of the full purchase price of any upgrade or new instrument of equal or greater value. Rental credit must be used immediately upon close of the rental agreement or it will be forfeited.

2. LATE FEES: Rent will be processed on due date. If payment can not be processed on the due date a **\$5 late fee per week will be assessed.** Rental agreements more than Sixty days (2 months) in arrears may be cancelled and the instrument must be returned to *The Violin Shop* within 72hrs.

3. You agree to notify *The Violin Shop* in writing when there is any change in your address, contact or payment information.

4. You authorize any private or public school employee, or any government agency, to disclose to us any information pertinent to this rental agreement or to the possible whereabouts of our instrument.

5. You authorize the Music Teacher or Principal to allow *The Violin Shop* or an agent thereof to pick up an instrument that is in default of this agreement.

6. *The Violin Shop* will cover normal "wear and tear" on items such as nicks, scratches, open seams and sticking pegs. **You are responsible for consumables and any damage beyond normal "wear and tear" including,** but not limited to: strings, broken bridges, bow repairs, broken necks, broken bows, loss or disappearance, damage from animals, the elements, automobile accident, fire, heat, windstorm, or theft. **Due to allergy and health concerns of Employees and future Renters, Returns covered with pet hair, pet urine stains or strong tobacco smoke smell will be charged for replacement.**

7. *The Violin Shop* is the owner of the rented instrument. This rental agreement is not transferrable. Renewal of this agreement is solely at the option of *The Violin Shop*. In the event of bankruptcy by the renter, the Rental Property remains the sole property of *The Violin Shop*. If payments are current, any rental equity may still be used towards the purchase of an outfit with any balance due in full at that time.

8. All provision of the agreement shall remain in force when the rented instrument is exchanged for another.
