RENTAL AGREEMENT

The instrument described herein is rented to the Customer signing below upon the following terms and conditions.

1. (a) This is a **School Year Rental** and expires next May 15th. *(Rentals started anytime May through August)*

(b) This is a **Calendar Year Rental** and expires next _____ / _____ (month/day).

INITIALS

Time is of the essence in this agreement. By signing below, you agree to pay a late rental fee of \$ _____ per day, plus any and all reasonable collection expenses, on instruments not returned by the expiration date. By retaining possession of the instrument for more than thirty days past the expiration date, you authorize us to charge the rental renewal fee to your credit or debit card. Return or repossession of the instrument does not remove your liability for the late fees or past due rent.

2. We will deduct the current year's rent from the purchase price of the rental instrument, or from the list price of any instrument of equal or greater value, **if purchased by the expiration date.** Time is of the essence in this agreement. Because we do not add finance charges, no more than one year's rent will apply to purchase. Rent does not accumulate toward purchase.

This is a rental agreement, not an installment or time sales agreement.

3. You may be entitled to a partial refund if the instrument is returned before the expiration date. Refund will be based on the difference between the rent actually paid and the higher posted monthly rate for the instrument, with a minimum three (3) month charge.

4. You agree to notify *The Violin Shop* in writing and prior to moving of any new address. We reserve the right to cancel this agreement and require the return of the rented instrument if you move out of our trade area. If we do so require, a straight pro-rated refund will be given. You authorize any private or public school employee, or any government agency, to disclose to us any information pertinent to this rental agreement or to the possible whereabouts of our instrument.

5. We will repair at no additional charge any malfunction or maladjustment which materially inhibits the playing of the instrument.

Repairs to the rented instrument shall be made solely by *The Violin Shop*.

6. You are responsible for consumables and any damage beyond normal wear and tear including, but not limited to: strings, broken bridges, bow rehairs, broken necks, broken bows, loss or disappearance, damage from animals (pet stains), tobacco smoke damage, the elements, automobile accident, fire, heat, windstorm, or theft. **Due to allergy and health concerns of Employees and future Renters, Returns covered with pet hair, pet urine stains or strong tobacco smoke smell will be charged for replacement.**

7. We reserve the right to change renewal rates at any time and to charge a higher rate if not paid by the expiration date.

8. The Violin Shop is the owner of the rented instrument. This rental agreement is not transferable. Renewal of this agreement is solely at the option of *The Violin Shop*.

9. If you pay the rental or any renewal by check, and the check is returned unpaid by your bank for any reason, the full declared value of the instrument shall become due and payable immediately.

10. All provision of the agreement shall remain in force when the rented instrument is exchanged for another.
