By my signature on this document I expressly assume these risks. I acknowledge that I am physically fit to scuba diver or snorkel and will not hold any of the above named individuals, persons, or entities responsible if I am injured as a result of a medical condition while I am scuba diving or snorkeling. I do not have in my possession any illegal drugs, nor am I taking, nor have I recently taken any drugs or medications, which could cause an adverse reaction as a result of combining such drugs and/or medication with scuba diving.

Prior to leaving the Dive Store I will thoroughly and completely inspect all of the equipment that I am renting and which will be used by me. If I discover any of my equipment is not functioning properly at any time I will cease all diving activities and promptly notify the Dive Store. I expressly agree not to hold the Dive Store or any of its employees, agents or assigns responsible for my failure to inspect my equipment prior to diving.

I understand that I have an affirmative duty to plan my dive. I agree to be responsible for my own safety. My signature and initials on this document affirm that I am fully aware of the dangers, risks and hazards of holding my breath while scuba diving and the dangers associated with rapid ascent. I certify that I am fully aware of the possibility that my equipment may malfunction during a dive which could include a free flowing regulator, stuck inflator button or unwanted inflation by my buoyancy compensator. I agree not to hold any of the individuals, or entities named within this document responsible for any such act.
