I hereby release the ski shop and its owners, agents and employees from any and all liability for damage and injury to myself or to any person or property resulting from the selection, adjustment and use of the equipment, accepting myself the full responsibility for any and all such damage or injury which may result.

I have made no misrepresentations to the ski shop in regard to my height, weight, age or skiing ability.

I verify that the visual indicators on my binding correspond to the settings as shown on this rental agreement form.

All instructions on the use of my rental equipment have been made clear to me and I understand the functions of my equipment.
