**Approved Minutes**  
November 12, 2025 – 7:00 PM

**Minutes:** J.Walker made a motion to accept the minutes as presented from the October regular meeting. B.Rogers seconded. Carried 4-0.

**Bills:** J.Walker made a motion to accept the October bills paid and the November bills to be paid, as presented. J.Love seconded. Carried 4-0.

**Public Forum:** Cathy Robb thanked the candidates for running for office and congratulated those elected. Becky Dewitt, on behalf of RDNCK Days, presented information on a community Thanksgiving dinner being hosted at the CCC on Thanksgiving Day, with meals being served at noon.

John Dupuis questioned whether the council is aware that the county commission is shutting down emergency dispatch services. Joe Love relayed that he did not believe that was factual information based on his communication at the county commission meeting.

Kathryn Prilliman asked the council who she should contact if a neighbor comes onto her property to try to hurt her animals. City council advised her to report alleged criminal activity to the Elk County Sheriff's Department.
