#### WAIVER AND RELEASE OF LIABILITY AGREEMENT

DISCLAIMER – This Waiver and Release Agreement is applicable to all renters, operators, passengers, and users of equipment provided by Boat in the Water, LLC \*(For purposes of this Waiver and Release, the term "Boat in the Water, LLC" includes all principles, directors, officers, employees, agents, representatives, servants, assigns, successors, insurers and subsidiaries of the Russellville Marina.). If any other rental agreement is supplemented with this Release, the provisions of this Release will prevail over any clauses in the rental agreement that is inconsistent with this Release. The undersigned agrees that he/she is also signing this Release on behalf of undersigned's minor children. Renter agrees that he/she will disclose to Boat in the Water, LLC all potential operators, passengers, and users of said rental equipment. Renter further agrees that in the a event that he/she fails to notify Boat in the Water, LLC of all potential operators, passengers, or users of said equipment, he/she will be personally liable for any damages to the undisclosed individuals, even if such damages arise out of the negligence or fault of Boat in the Water, LLC.

**EXPRESS ASSUMPTION OF RISK** - The undersign herby agrees that he/she is renting, operating or using the equipment provided by Boat in the Water, LLC at his/her own risk.
