### **Legislative News**

In previous newsletters, we have reported the struggles, at the federal, state, and county levels, to keep our industry alive. The next Maryland legislative session begins in early January and so far, we have not heard of any potential bills that would crush our industry. As time progresses, we will keep you informed on any/all state legislation.

### **Firearms Training**

Maryland has recently been changed to a “shall issue” state. Per the July 22, 2022, Maryland State Police news release, *“Pursuant to the recent Supreme Court ruling, on July 5, 2022, Governor Larry Hogan directed the Maryland State Police to suspend the ‘good and substantial reason’ standard to wear, carry or transport a regulated firearm on your person. Before you may legally wear and carry a regulated firearm, you must possess, and maintain on your person at all times, the Maryland State Police issued Handgun Wear and Carry Permit....Maryland does not recognize handgun permits issued by any other state”*.

Chalet Firearms Training is finally open & operational to assist with obtaining many firearms certifications and training. As supporters of the Second Amendment and our right to legally bear arms, they offer training in several areas: Wear & Carry Permits for Maryland (and other states), Handgun Qualification License (HQL) which is needed to purchase a handgun in Maryland, Permit Renewals, Real Estate Agent training, 1-on-1 private training, and more. It is imperative to have proper training on conflict deterrence, avoidance, and if necessary, defense of one's own life or the life of another.
