All participants must be at least 12 years old. All participants under 18 years old must be accompanied by a participating adult in the water. For the Swim Program, there is a maximum of 7 children (ages 12-17) per participating adult. For the Dive Program, there is a maximum of 7 children (ages 15-17) per participating adult and EACH child ages 12-14 must be accompanied by a participating adult. All Swim or Dive participants under 18 years of age must have the program liability waiver signed and dated by their PARENT OF CUSTODY or COURT APPOINTED LEGAL GUARDIAN. Waivers signed by those other than a parent or court appointed legal guardian will not be accepted. Guests with special needs should inform the dive team prior to your event date to review your requirements, mobility, and equipment. We will be happy to make any reasonable accommodations to improve the quality of your experience. We have designed the locker room and dive platform to meet ADA regulations. Guests who will be participating in the SCUBA program must have proof of Open Water certification from a nationally or internationally recognized organization.

*Diving Journey with Gentle Giants Participants must be at least 12yrs old and Scuba Certified.

*Shark Cage Diving Participants must be at least 12yrs old, Scuba Certification not required.
