By signing this release and waiver form, I certify that I am aware of and comprehend the risks involved, and voluntarily assume the risks of engaging in these outdoor activities as well as being on the premises of Bonneville Seabase.

Having been informed and trained in certain skills of snorkeling and SCUBA Diving, we agree to remain within the range of my personal diving abilities. Furthermore, I hereby release BONNEVILLE SEABASE, and all those affiliated in any manner therewith, from any and all responsibility for my safety or my actions while using their facilities and/or equipment. This release and waiver is intended to legally prevent me and/or my estate from asserting and claim, demand, damages, action, or cause of action on account of damage to property, bodily injuries, or death resulting from an accident or mishap while participating in or preparing for any outdoor or water related activity; including but not limited to, any Snorkeling or SCUBA Diving procedure.

I agree to comply with all rules adopted by BONNEVILLE SEABASE. Furthermore, I agree to adhere to the standard safe diving practices and procedures adopted by recognized SCUBA diving organizations; said standards being incorporated by this reference as if the same were set forth entirely herein. Given the evolving nature of water-related sports, I recognize that I might possibly not be aware of the entirety of the above-mentioned practices and procedures, yet I specifically agree to be bound by the same nonetheless. My failure to abide by these standards shall constitute an irrefutable defense to any claims I or my estate may assert for injury or damage resulting from any of the inherent risks of SCUBA and water-related activities, including, but not limited to, equipment functionality and/or physical surroundings. I further agree to provide financial remuneration to BONNEVILLE SEABASE for any damage caused by me or through my actions, to its facilities or inhabitants or animals.

My signature directly below signifies that it is understood and agreed that this written instrument is a full and final release of all claims of every nature and kind whatsoever, and that this instrument releases all claims that are known and unknown, suspected and unsuspected.
