Due to the high cost of training materials, they ask that individuals be committed before registering and going through the training process. Classes start on February 15, 2022. ## Item: 5 Audit-End of Fiscal Year 9-30-2021

Each council member was given a financial statement booklet. John with Zwygart CPA's presented the completed audit to the city council. Balance sheets for each fund and account were reviewed thoroughly. John reviewed the list of detail assets and depreciation values.

The General, Water, Sewer, and Garbage Funds were all reviewed, and questions were answered.

The balance sheet showing profit and loss for the general fund were presented and explained.

The checking, savings and reserve accounts were reviewed thoroughly.

The (DEQ) Department of Environmental Quality water bond loan is current.

The skid steer/236D CAT was paid off early during the 2021 year, saving approximately \$443.00 in

The sanitation fund is sitting well with reserves.

Council members were advised to continue being conservative with spending.

John advised the council to continue working with DEQ and IRWA to incorporate a financial plan for realigning the sewer ponds. Council will eventually have to raise the sewer rates in order to get a bond. John informed the council that the audit is clean; all funds and accounts are in good order.

There are no concerns regarding the financial statements for Fiscal Year 2020-2021.
